- Don't like the inclusion of "public" puts our reference on a second tier of quality
- Focus needs to be narrowed down premier in what?
- Should we have national aspirations? Is a regional focus more realistic?
- How will we know when it is achieved?

What is the most important priority for Truman over the next five years?

- Preserving our reputation through these difficult economic times
- Being fiscally responsible
- We need to prepare to deal with the demographic shifts in the students who come to Truman that are going to happen while staying true to our mission
- Maintain or enhance our academic quality and high expectations of students
- Need to broaden the area from which we recruit
- Need to have better outreach to and financial aid for underrepresented groups
- Need to maintain undergraduate research opportunities and small class sizes
- The number one complaint we get is the lack of course availability this hurts current students and the recruitment of potential students
- We need to develop efficiencies in the registration process
- Need to continue and enhance the use of assessment to demonstrate the value of what we do
- We need to see the financial challenges that we are facing as an opportunity to change for the better – poor morale results from the lack of innovative thinking and a willingness to try new things – we need to get energized by the possibilities

## Budget:

Decrease in State funding; an increase in fees

# Technology:

- More and increasing expense for technology
- Need upgrades frequently

#### **Political Realities:**

- Lack of faith on the part of State and federal governments regarding how higher education uses funds and the lack of documentation of results
- Turn over in the State legislature

# **Student Needs and Expectations:**

- More poorly prepared students
- Our students need more developmental skill works
- Need to refine admission screening and then create strategies to support students whom we admit better
- The needs of transfer students should be a priority
- We need more innovative articulation agreements

## **Higher Education Practices:**

- Increasing peer lead academic support
- Peer mentoring programs
- Hybrid courses combining technology and traditional face to face teaching strategies
- We need to do a better job or articulating the importance of the residential component to learning outcomes and the power of student interactions with each other
